

Fees

Start Afresh Mediation · Effective for all Agreements to Mediate signed on or after 1 September 2026

Mediation packages

Each package costs less than booking the same elements separately. All prices below are **per person**.

Children — £570 per person · package saving £80

MIAM, 2 joint sessions (90 minutes each), and a Parenting Plan

Includes the £500 government voucher, which reduces your fee by £250 per person.

Property and Money — £1,325 per person · package saving £150

MIAM, 3 joint sessions (90 minutes each), an Open Financial Statement, and a Memorandum of Understanding

The government voucher is not available where mediation concerns finances only. If your case also involves arrangements for children, you may be eligible — we will check at your MIAM.

Children, Property and Money — £1,500 per person · package saving £200

MIAM, 4 joint sessions (90 minutes each), a Parenting Plan, an Open Financial Statement, and a Memorandum of Understanding

Includes the £500 government voucher, which reduces your fee by £250 per person.

Voucher eligibility is assessed at your MIAM and vouchers are subject to government funding. Where a voucher is not available, the Children package is £820 per person and the Children, Property and Money package is £1,750 per person.

Notes

1. Sessions are held online by default. In-person attendance can be arranged on request, subject to availability, at a 20% uplift per person plus room hire and travel at cost.
2. Sessions outside working hours (Monday to Friday, 10.00–17.00) are charged at a 20% uplift. The uplift does not apply to Priority MIAMs. Uplifts are not cumulative: where more than one applies, only a single 20% uplift is charged.
3. Fees are payable in advance of each session or document unless agreed otherwise in writing.
4. Room hire and travel, where required, are charged separately at cost.
5. Package fees are payable in two instalments: the MIAM fee on booking, the balance before the first joint session. If mediation ends before completion, the elements delivered are charged at the individual prices above and the balance refunded. Packages are valid for six months from the date of the Agreement to Mediate.
6. Priority MIAM appointments are subject to availability.
7. This Price List forms Appendix 1 to the Agreement to Mediate and is binding for six months from the date the Agreement is signed. After that period the current published Price List applies. You will be given at least 30 days' written notice of any change, and you may end the mediation at any time without penalty; any fees paid in advance for services not yet delivered will be refunded.
